

NOTICE OF CHANGES TO PROPOSED REGULATIONS AND ADDING DOCUMENTS TO THE RULEMAKING FILE

Concerning Inmate Participation and CALPIA Worker Hiring Standards

(**Z-2020-0406-01**)

The California Prison Industry Authority (CALPIA) is providing notice of proposed changes to CALPIA's regulations concerning inmate employment which were published in the California Regulatory Notice Register on April 17, 2020. CALPIA is providing notice of these proposed changes and an opportunity for public comment in accordance with Government Code section 11346.8(c) and California Code of Regulations (CCR), Title 1, section 44.

A copy of the proposed text with the new changes illustrated is attached, with additional proposed regulation text indicated by a double <u>underline</u> and deleted proposed regulation text indicated by a double <u>strikethrough</u>. For the internet posting of this notice, the regulation text is posted as a separate document in conjunction with this notice.

CALPIA is also providing notice that an Addendum to the Initial Statement of Reasons (ISOR) and an Addendum to the 45 day notice will be added to the rulemaking file in accordance with Government Code section 11347.1. The Addendum to the 45-day notice is being added to clarify and correct statements in the 45-day notice. The Addendum to the ISOR is added to the rulemaking record to to provide the rationale for several substantive and non-substantive changes to the modifications to section 8004.2 and to correct statements made in the original ISOR. For the internet posting of this notice, the Addendum to the ISOR and the Addendum to the 45-day notice are posted as separate documents in conjunction with this notice.

REVISIONS TO ORIGINALLY PROPOSED TEXT:

The originally noticed text is changed as follows. With respect to (f)(4), the words "a final list of successful inmate applicants" will not be deleted from its existing text. Also in subsection (f)(4), the words "on the" replace "in writing." Next, in subsection (f)(4), the first letter is capitalized for the name of the form "Job Change Request Form" and ", hereby incorporated by reference" is added after the identification of the form.

The newly added subsection (i) is changed from the originally noticed text to add after the words review and signature the words "on the Acknowledgement form" and adding ", hereby incorporated by reference" after the identification of the form.

The proposed text is also changed on the Inmate Acknowledgement of Polices, Procedures, Rules and Regulations to add the words "(as listed below)" after the words: "This acknowledges that I understand there are rules, regulations, polices and procedures". In addition, at the end of this form, five blank lines are added after the added words: "Rules, Regulations, Policies and Procedures acknowledged:" Lastly, the revision date at the bottom of the Acknowledgement is changed from "(Rev. 3/5/2020)" to "(Rev. 8/1/2020), and the form number is being changed from "IEP F002/F003" to "IEP F029.".

Subdivision (f)(4) is changed from the originally noticed text to leave the language "final list of successful inmate applicants" and add the text of "Job Change Request Form (CALPIA FORM SOMS F001 (3/26/2016))" to correctly name the form.

INCORPORATION BY REFERENCE:

Two forms are being incorporated by reference in section 8004.2: "Job Change Request Form (CALPIA FORM SOMS F001 (3/26/2016)) and Acknowledgement Form (CALPIA FORM IEP F029 (8/1/2020)). During this 15-day notice of changes period, Form IEP F002/F003 was updated to Form IEP F029 is being updated from revision date 3/5/2020 to 8/1/2020, in order to add additional lines for entry of specific rules, regulations, and polices and the words ("as listed below") were added to the first line of the first full paragraph after the words "policies and procedures."
