

## New CDCR Secretary and Chair of the Prison Industry Board

On December 28, 2015, Governor Brown appointed Scott Kernan as the new Secretary of the California Department of Corrections and Rehabilitation (CDCR). As Secretary, he will also serve as the Chairman of the Prison Industry Board (PIB). Kernan replaces Jeffrey Beard who departed.

"I have always had a respect for the work that California Prison Industry Authority does, both in the way of rehabilitative programs and the work that they do with prison to make it a safer place," said Kernan, who chaired his first PIB meeting on January 28, 2016.

The PIB oversees CALPIA operations and consists of 11 members, including 8 appointees from the Governor, Senate and Assembly. It sets general policy for CALPIA and oversees the performance of existing CALPIA industries as well as the performance of the CALPIA General Manager.

Secretary Kernan served as CDCR Undersecretary for Operations from March to December 2015. He was owner at Kernan Consulting from 2011 to 2015. He served as Undersecretary for Operations at CDCR from 2008 to 2011. He was Chief Deputy Secretary of Adult Operations from 2007 to 2008 and Deputy Director of Adult Institutions from 2006 to 2007.



His prior experience includes serving as Warden at California State Prison, Sacramento, Warden at Mule Creek State Prison, Chief Deputy Warden, Correctional Administrator, Captain, Lieutenant, Associate Budget Analyst, Sergeant and a Correctional Officer from 1983 to 1985. Secretary Kernan also served in the U.S. Navy from 1979 to 1982.

On October 13, 2015, Facebook founder and CEO Mark Zuckerberg toured the Code.7370 program at San Quentin State Prison.

Zuckerberg and his wife, Dr. Priscilla Chan, joined Warden Ron Davis, Prison Industry Board Vice-Chair Darshan Singh, and CALPIA's General Manager Chuck Pattillo for a tour around the prison and coding program.

Code.7370 is a nationally recognized program which teaches offenders coding skills without internet access.

"The real-world job experience this computer coding class provides is beneficial to offenders and the general public," said Pattillo. "If a person can leave prison, get a job and not come back, it saves taxpayers' money and keeps communities safer."

"You know that's how I got started — coding," Zuckerberg told offenders.

Zuckerberg met and talked with offenders from the Code.7370 program. After observing offender projects, he wanted to know how the class was taught, what they were learning and

how many hours a day they spent coding.

"It's special when you can have an innovator come inside a world that is disconnected from most innovations to learn about our community and effort to rehabilitate people... it's extraordinary. As one of the most accomplished visionaries of our time, I am sure his interest in public safety and criminal justice issues will spark broader conversations and solutions to benefit all," said Warden Davis.

# Preparing Women for Success in Mechanical Drafting, Engineering & Architecture

Eighteen female offenders graduated from CALPIA's AutoDesk Authorized Training program at Green Valley Training Center on November 19. Graduates from the Folsom Women's Facility were enrolled in the program which provides training in AutoCAD (Computer-Aided Design), AutoDesk Revit and Autodesk Inventor.

"The certifications the women receive in this program will help them get jobs in architectural, mechanical and/or engineering fields," said Rusty Bechtold, Work Force Development Branch Administra-

tor. "We want offenders to get jobs and be successful when they leave prison; we don't want them to return."

This program is the only authorized AutoDesk Training Center housed at a correctional facility. Course participants are required to have some computer experience, math skills, and a general education (GED) certificate, at minimum. AutoCAD and Inventor are a combined curriculum that takes approximately six months to complete. AutoDesk Revit alone requires a six-month-long curriculum.



# High-Profile Graduation for CALPIA's Code.7370 Program

More than 150 guests, including MC Hammer, turned out for CALPIA's Code.7370 graduation at San Quentin State Prison. Thirteen offenders graduated from the renowned computer coding program, the first-of-its-kind in the nation, where offenders learn computer coding skills in order to become more employable when they leave prison.

The program is managed through CALPIA in collaboration with the California Department of Corrections and Rehabilitation (CDCR) and The Last Mile. The program's curriculum simulates a live-coding environment without Internet ac-

cess. Silicon Valley's technology business community developed the course syllabus and helps administer the instruction.

The Last Mile also held Demo Day, where offenders demonstrated their apps to the Silicon Valley business community. MC Hammer provided words of encouragement as the keynote speaker. Other speakers included: CALPIA's General Manager Chuck Pattillo, Warden Ron Davis, Acting Director of CDCR's Division of Rehabilitative Programs Brant Choate, and The Last Mile Co-Founders Chris Redlitz and Beverly Parenti.

On August 6, 2015, the first graduation for the Pre-Apprentice Construction Laborers program was held at San Quentin State Prison. This program is part of CALPIA's Career Technical Education (CTE) program, which has a cumulative

recidivism rate of 7.13%.

On a stage built by the eight graduates, correctional staff recognized each one for completing the program and praised two offenders in particular who exceeded program expectations.

After parole, program graduates have the opportunity to apply for positions with local labor unions. If hired, the CTE program pays their first year of union dues and provides them with a set of tools necessary for work.
